IAI achieved a top rating for environmental policies, with initiatives like Green Teams that monitor our robust energy and water conservation, recycling programs, ISO 14001 certification audits, heating and cooling optimization, and carpooling/public transportation encouragement.

LABOR & HUMAN RIGHTS RATING: ADVANCED, 70/100

A safe workplace is one that cares about each person in the process and continually strives to improve the lives of everyone in our environment. That's why we promote the mental and physical health of our team members and community by promoting biking to work, providing fresh fruit, expanding our PPE package, and supporting incident, accident and unsafe situations reporting and follow-up.

We've also crafted an in-depth Modern Slavery Statement to ensure that no form of modern slavery occurs in any part of our business or supply chain. We're committed to conducting monthly partner and direct supplier audits. We require all new and acquired employees to complete a training course on modern slavery and human trafficking within the first three months of joining our company and every three years thereafter.
